## Sir Peregrine Maitland's Prize

The Vice-Chancellor gives Notice, that the Prize will this year be given for the best Essay on the following subject:

"The Organization of a Native Indian Church, with special reference to (a) local requirements, (b) the existence in India of various forms of Western Christianity, and (c) the importance of Church Unity."

Candidates for the Prize must be graduates of the University, who are not .

of more than ten years' standing from admission to their first degree, when the exercises are sent in.

The Essays must be sent to the Vice-Chancellor before the 10th day of November, 1879, each bearing some motto, and accompanied by a sealed paper, bearing the same motto, and enclosing the name of the Candidate and that of his College.

The adjudicators are the Vice-Chancellor, Dr E. H. Perowne, and C. E. Searle, M.A., of Pembroke College.

## GRACES

Notice is hereby given that there will be a Congregation on Wednesday, the 11th of December, at Two o'clock P.M., at which the following Graces, having received the sanction of the Council of the Senate, will be offered to the Senate.

N.B. No degrees will be conferred at this Congregation.

That in the place of the provisions contained in Chap. VII. Sec. 4, Par. 2 of the University Statutes, it be provided by Statute that the Court of discipline for offenders in statu pupillari shall consist of the Chancellor and six Heads of Colleges appointed by Grace of the Senate to serve for three years, in such manner that two of the six shall go out of office every year, but be capable of re-election, and that no sentence involving suspension of Degree, rustication or expulsion, be valid without the concurrence of the Chancellor and three, at least, of the other members of the Court.

If the Head of the College, to which any person charged with any offence may belong, be not a Member of the Court, notice shall be given to him to enable him to be present as an assessor. But he shall not be entitled to give a vote. Regulations for the procedure of the Court shall be made by the Court from time to time, subject to the approval of a Grace of the Senate.

That the offices of Public Orator, Registrary and Librarian being retained as Statutable Offices of the University, it be in the power of the University to vary their duties by Grace of the Senate from time to time.
